Know all by these presents that the undersigned's hereby makes, constitutes and appoints each of Jill Golder, Noel Tippett, Heidi White, Donald Kappel, Dana Reavis and Richard Wolfson, acting singly with full power of substitution and delegation, as the undersigned's true and lawful attorney-in-fact, with full power and authority as hereinafter described on behalf of and in the name, place and stead of the undersigned to:
